Regulations for Outstanding Youth Selection

Article 1 National Taiwan University (NTU or “the University”) formulates the NTU *Regulations for Outstanding Youth Selection* (“the Regulations”) to recognize and reward students who demonstrate both exemplary character and academic excellence, along with specific outstanding achievements.

Article 2 NTU Students (including those graduating in the current academic year) who meet the following criteria may be nominated as a candidate for the NTU Outstanding Youth Awards:

1. A GPA of 2.93 or above in the previous semester
2. No warnings or demerits issued during their period of study
3. Demonstration of specific outstanding achievements

The specific outstanding achievements referred to in Subparagraph 3 of the preceding paragraph shall be any of the following:

1. Demonstration of exemplary character, diligence, and exceptional academic/ research performance
2. Acts of patriotism or significant contributions to the University
3. Dedication to public welfare and social services that sets an example for other youth
4. Excellence service as a student club officer
5. Other notable and exemplary deeds

Article 3 Students who meet the criteria listed in the preceding Article may apply for the Outstanding Youth Selection by submitting a recommendation form and required documents to their respective college by the college’s announced deadline.

Each college shall conduct a preliminary review after receiving applications mentioned in the preceding paragraph, compile a list of recommended candidates (in ranked order), and submit it to the Office of Student Affairs for selection by the Outstanding Youth Selection Committee (“the Committee”).

The number of candidates each college may nominate shall be determined proportionally based on its total number of students, with one candidate per

1,000 students. For a college with fewer than 1,000 students, the baseline for nominations will be set at 1,000 students.

Article 4 The Committee shall consist of two ex officio members and several other members, with the Vice President for Student Affairs serving as the convener and chair of the Committee:

1. The Vice President for Student Affairs and the Vice President for Academic Affairs shall serve as ex officio members
2. Each college shall nominate one faculty member to serve on the Committee.

The colleges mentioned in the preceding paragraph refer to those listed in Appendix 1 referenced in Article 12 of the NTU Organizational Charter (excluding the professional schools).

Article 5 The Committee shall select several outstanding youth awardees from among the candidates. The final list shall be determined by the Committee based on its judgment.

The awardees shall be commended and presented with a certificate by the University or an organization not affiliated with NTU.

Article 6 The Regulations shall be passed by the Administrative Meeting and then implemented on the date of promulgation.
